HOUSE RULES

Effective: 10 March 2014

- 1. Profane and/or abusive language shall not be used in the club rooms at any time.
- 2. There will be no horseplay which might cause bodily harm to a member or guest.
- 3. No person shall remove property of any description from the building without the written permission of the President.
- 4. No person shall be allowed to use the Club rooms for living quarters at any time.
- 5. Any member may use the Club rooms for special activities, but the President must first be consulted.
- 6. The Veterans of Lansingburgh assumes no responsibility for any lost or missing articles.
- 7. No person shall engage in illegal activities or conduct that will bring discredit upon themselves, a fellow member, or the Veterans of Lansingburgh property.
- 8. No person shall deface or destroy any property.
- 9. Non-members (including children) must be accompanied by a member. Children are allowed at the front bar area at the tables. No one under the age of 21 is allowed at the bar. Children brought into the club will be kept under the supervision and responsibility of their parents and the member who sponsored them at all times.
- 10. No Member shall charge any purchases to the Club without the expressed permission of the President or Vice President.
- 11. The number of guests is determined at the discretion of the President or the Bartender.
- 12. Any members bringing guests of legal drinking age are responsible for said guests.
- 13. The Bartender or President has the right to refuse to serve any member or guest at their discretion. Members or guests will be requested to vacate the premises promptly. Members not complying may be subject to disciplinary action.
- 14. All guests must be accompanied by a Member.
 - a.) All guests will be signed in by the Member sponsoring them;
 - b.) Any Member signing in a guest is held fully responsible for said guest;
 - c.) All guests will depart the Club when their sponsor leaves. There are no exceptions to this rule.
 - d.) Any Member failing to sign in a guest may be subject to disciplinary action.
- 15. The parking lot is not to be used as a private parking lot. It is intended for use by members while they are visiting the Club.
 - a.) Handicapped parking will be strictly enforced.
- 16. All coats will be hung on the coat racks or hooks under the bar. No coats will be hung on barstools or chairs.
- 17. Purses are to be hung on the hooks under the bar; there are to be no purses on the bar.
- 18. There are no glasses or bottles allowed outside or under the Pavilion.
- 19. NO SMOKING inside the club. Violators are subject to disciplinary action.
- 20. In the absence of the Officers or Board of Directors, the bartender is in charge. The bartender speaks for the organization and their decision is final. Disagreements with the decisions should be directed to the Bar Chairman and the President.
- 21. When asked by the bartender, Club Officer or Board of Director, patrons will produce an up-to-date Club membership as proof of member in good standing.
